

NOTICE OF ELECTION

Parliamentary Election for the

CENTRAL DEVON CONSTITUENCY

1. An Election is to be held of One Member of Parliament for the Central Devon Constituency.
2. Forms of nomination for the Parliamentary Election may be obtained at West Devon Borough Council, Kilworthy Park, Tavistock, Devon, PL19 0BZ from the Acting Returning Officer who will, at the request of an elector for any electoral area, prepare a nomination paper for signature.
3. Nomination papers must be delivered to the Acting Returning Officer, Election Office, West Devon Borough Council, Kilworthy Park, Tavistock, Devon, PL19 0BZ on any day after the date of this notice (excluding Saturday, Sunday and Bank Holidays) between the hours of 10am and 4pm but **no later than 4pm on Thursday, 14 November 2019**.
4. At the same time as delivering the nomination paper, candidates must also supply a £500 deposit which must be made either by the deposit of cash (legal tender) or by means of a United Kingdom banker's draft .
5. If the election is contested the poll will take place on **Thursday, 12 December 2019** between the hours of 7am and 10pm.
6. Applications to vote by post, or to change or cancel an existing postal vote, proxy appointment or postal proxy arrangement must be received by the appropriate Electoral Registration Officer not later than **5pm on Tuesday, 26 November 2019**.
7. Applications to vote by proxy at this election must reach the appropriate Electoral Registration Officer by **5pm on Wednesday, 04 December 2019**.
8. Applications to vote by proxy at this election applied for on grounds of physical incapacity, where that physical incapacity occurs **after 5pm on Wednesday, 04 December 2019** or on grounds of occupation, service or employment, where the elector becomes aware that they cannot go to the polling station in person **after 5pm on Wednesday 04 December 2019**, must reach the appropriate Electoral Registration Officer **by 5pm on Thursday, 12 December 2019**.
9. Applications to be included on the Register of Electors can be made online at www.gov.uk/registertovote or complete a form available from the council offices. The deadline for applications to be received is **Tuesday, 26 November 2019**.
